What data do we collect?

Cardetail collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Your behaviour during your stay at the website to optimize your experience

How do we collect your data?

You directly provide Cardetail with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards (forms) or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Our Company collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.
- Optimize our website for your and other visitors

If you agree, Cardetail will share your data with our partner companies so that they may offer you their products and services.

When Cardetail processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Cardetail securely stores your data at our webhosting provider, Versio. And locally within Lennert Vermijl.

Cardetail will keep your data for 5 years. Once this time period has expired, we will delete your data on our servers.

Marketing

Cardetail would like to send you information about products and services of ours that we think you might like, as well as those of our partner companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Cardetail from contacting you for marketing purposes or giving your data to other members of Lennert Vermijl.

If you no longer wish to be contacted for marketing purposes, please contact us.

What are your data protection rights?

Cardetail would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Cardetail for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Cardetail correct any information you believe is inaccurate. You also have the right to request Cardetail to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Cardetail erases your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Cardetail restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Cardetail's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Cardetail transfers the data that we have collected to another organization, or directly to you, under certain conditions.

Cookies

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

How do we use cookies?

Cardetail uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website
- Target you on other channels like social media

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – Cardetail uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could

include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

- Advertising – Cardetail uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Our Company sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
